

SOFTWARE LICENSE AND USER AGREEMENT

This Software License Agreement ("Agreement") is a legally binding agreement between **Freethink LLP** ("Licensor") and any individual or entity ("Licensee" or "You") that installs, runs, or otherwise accesses the software platform known as **mapflows** (the "Software").

By downloading, installing, copying, or using the Software, You agree to be bound by the terms of this Agreement. Where the Software is supplied pursuant to a separately executed agreement, purchase order, work order, statement of work, license order, government contract, or similar written instrument ("**Commercial Agreement**"), the Commercial Agreement shall govern commercial matters and any expressly negotiated terms that conflict with this Agreement.

1. Grant of License

- **Scope:** Licensor grants Licensee a limited, non-exclusive, non-transferable license to install, execute, access and use the Software solely for the Licensee's internal business, administrative, governmental, institutional and operational purposes, including operation of applications, workflows, portals and services configured using the Software. The license is limited to the Software version supplied to Licensee and no additional license fee is applicable for continued use of the same software.
- **No Distribution or Sublicensing:** Licensee shall not sell, rent, lease, sub-license, lend, host as a white-label service, or commercially redistribute the binary packages or installer files of the Software to third parties without prior express written authorization from Licensor.

2. Reverse Engineering Restrictions

- **Binary and Object Code Only:** The Software is distributed strictly in compiled binary and object code format. No license, express or implied, is granted to inspect, view, or access the source code of the underlying runtime engine.
- **Anti-Decompilation:** Except to the extent non-waivable statutory law explicitly permits otherwise for system interoperability, Licensee shall not:
 - Reverse engineer, decompile, decrypt, disassemble, or derive the source code, architecture, or algorithmic structure of the Software;
 - Modify, patch, translate, or create derivative works of the compiled binaries or core execution libraries;

3. Extensibility and Database Access

- **Permission to Extend:** The Software is a no code platform that allows UI and Workflow changes to be executed without the need to write code. It utilizes an external database to manage business rules, UI layouts, workflow definitions, and application metadata. Licensor expressly permits Licensee to:
 - Query, inspect, and update configuration parameters, and metadata stored within the connected open source database;
 - Engage internal staff or contracted technical third parties to maintain and adapt these database configurations, provided such third parties act strictly on behalf of Licensee and comply with the proprietary restrictions herein.
 - Author external automation scripts, database triggers, API integrations, and queries to interact directly with the database;
- **Liability Disclaimer:** Licensor shall not be responsible for failures, corruption, loss or unavailability caused by unauthorized, improper or unsupported modifications to the database schema or system metadata by Licensee or any third party acting under Licensee's authority.

4. Termination: Licensor may terminate the license upon material breach by Licensee if such breach remains uncured for thirty (30) days following written notice.

5. Intellectual Property & Asset Separation

- **Licensor Retains Software IP:** Licensor retains all title, rights, ownership, copyrights, trade secrets, patents, and other intellectual property rights in and to the Software, the binary images, the proprietary engine framework, and all associated technical documentation.
- **Licensee Retains Data & Custom Logic:** Licensee retains ownership of all operational business data, documents, transaction logs, uploaded files, and custom database configuration metadata authored by or for Licensee.

6. Updates, Support, and SLAs

- **"As-Is" Distribution:** This license does not entitle Licensee to automated updates, future major version releases, patches, bug remediation, technical support, or Service Level Agreements (SLAs).
- **Optional Paid Services:** Any implementation support, maintenance contracts, custom development, or guaranteed response times are governed by separate, independent commercial agreements.

7. Disclaimer of Warranties

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE SOFTWARE IS PROVIDED "AS IS" AND "AS AVAILABLE," WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT. LICENSOR DOES NOT WARRANT THAT THE SOFTWARE WILL OPERATE UNINTERRUPTED OR ERROR-FREE.

8. Limitation of Liability

IN NO EVENT SHALL LICENSOR BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES (INCLUDING LOSS OF PROFITS, DATA CORRUPTION, BUSINESS INTERRUPTION, OR PROCUREMENT OF SUBSTITUTE GOODS) ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

9. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of **Goa, India**, without regard to conflict of law principles. Any dispute arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the competent courts of **Panaji, Goa**.
